Prospective tenants have the right to provide a portable tenant screening report (PTSR), as defined in Section 38-12-902(2.5), Colorado Revised Statutes. If an applicant provides a PTSR, there is no rental application fee. However, the report MUST be dated within 30 days of its submission to CLPM. A copy of a current photo ID must accompany every application.
